2019 US Annual Conference actions on Traditionalist Plan or its alternatives
28 of 54 (in Bold) took action against Traditional Plan

DAKOTAS	Voted to "eliminate discriminatory language in church rules."
EAST OHIO	52% approved the 4 affirmations of UMCNext, but 2/3rds required to pass
ILLINOIS GREAT RIVERS	No resolutions.
INDIANA	Resolution was ruled out of order and not considered
IOWA	Disavowed the Traditionalist Plan by over 68%.
MICHIGAN	Resolution to live as if the simple plan passed.
MINNESOTA	Disavowal of the Traditionalist Plan
NORTHERN ILLINOIS	Several resolutions in opposition to Traditionalist Plan.
WEST OHIO	No resolutions.
WISCONSIN	Disavowal of the Traditionalist Plan
BALTIMORE-WASHINGTON	Petitions were referred to a committee.
EASTERN PENNSYLVANIA	Declared themselves a "One Church Plan Conference in spirit"
GREATER NEW JERSEY	Held special session earlier and declared themselves a "One Church Plan Conference"
NEW ENGLAND	Approved resolution "Aspiring to Live in Non-Conformity"
NEW YORK	Vowed opposition to the Traditionalist Plan.
PENINSULA-DELAWARE	Petition was withdrawn by the maker.
SUSQUEHANNA	No resolutions.
UPPER NEW YORK	Condemned the Traditionalist Plan
WEST VIRGINIA	No resolutions.
WESTERN PENNSYLVANIA	No resolutions.
ARKANSAS	No resolutions.
CENTRAL TEXAS	Adopted the 4 UMCNext affirmations, including resistance to TP.
GREAT PLAINS	Condemns and resists Traditionalist Plan and affirms 4 UMCNext points.
LOUISIANA	Petition opposing Traditional Plan fails by 20 votes
MISSOURI	Supported funding for LGBTQ persons
NEW MEXICO	No resolutions.
NORTH TEXAS	Passes a One Church Plan resolution.

NORTH ALABAMA	Resolution apologizing to LGBTQ community for TP fails.
NORTH CAROLINA	Called for a repeal of the Traditionalist Plan with 60% vote.
NORTH GEORGIA	No resolutions.
RED BIRD MISSIONARY	
SOUTH CAROLINA	Opposition to Traditionalist Plan resolution ruled out of order by bishop.
SOUTH GEORGIA	No resolutions.
TENNESSEE	Apologized for harm to LGBTQ community.
VIRGINIA	Approved removal of incompatibility language and called for delay to all trials.
WESTERN NORTH CAROLINA	Approved the UMCNext affirmations by 63%.
ALASKA	Approved all four of UMCNext affirmations
CALIFORNIA-NEVADA	Rejects and condemns the Traditionalist Plan.
CALIFORNIA-PACIFIC	Disavowal of the Traditionalist Plan
DESERT SOUTHWEST	Disavowal of the Traditionalist Plan
MOUNTAIN SKY	"reject(s) and will not enforce" the Traditionalist Plan
OREGON-IDAHO	Stipulates Traditionalist Plan as unacceptable
PACIFIC NORTHWEST	Denounced actions of 2019 and committee to non-compliance.
